The previous 17 presidencies of the G20 delivered significant results for ensuring macro-economic stability, rationalising international taxation, relieving debt burden on countries, among many other outcomes. We will benefit from these achievements, and build further upon them.

However, as India assumes this important mantle, I ask myself, can the G20 go further still? Can we catalyse a fundamental mindset shift, to benefit humanity as a whole?

I believe we can.

Our mindsets are shaped by our circumstances. Through all of history, humanity lived in scarcity. We fought for limited resources, because our survival depended on denying them to others. Confrontation and competition – between ideas, ideologies and identities – became the norm.

Unfortunately, we remain trapped in the same zero-sum mindset even today. We see it when countries fight over territory or resources. We see it when supplies of essential goods are weaponised. We see it when vaccines are hoarded by a few, even as billions remain vulnerable.

Some may argue that confrontation and greed are just human nature. I disagree. If humans were inherently selfish, what would explain the lasting appeal of so many spiritual traditions that advocate the fundamental oneness of us all?

One such tradition, popular in India, sees all living beings, and even inanimate things, as composed of the same five basic elements – the panch tatva of earth, water, fire, air and space. Harmony among these elements – within us and between us – is essential for our physical, social and environmental well-being.

India's G20 presidency will work to promote this universal sense of oneness. Hence our theme: "One Earth, One Family, One Future."

This is not just a slogan. It takes into account recent changes in human circumstances, which we have collectively failed to appreciate.

Today, we have the means to produce enough to meet the basic needs of all people in the world.

Today, we do not need to fight for our survival – our era need not be one of war. Indeed, it must not be one!

Today, the greatest challenges we

face – climate change, terrorism, and pandemics – can be solved not by fighting each other, but only by acting together.

Fortunately, today's technology also gives us the means to address problems on a humanity-wide scale. The massive virtual worlds that we inhabit today demonstrate the scalability of digital technologies.

Housing one-sixth of humanity, and with its immense diversity of languages, religions, customs and beliefs, India is a microcosm of the world.

With the oldest-known traditions of collective decision-making, India contributes to the foundational DNA of democracy. As the mother of democracy, India's national consensus is forged not by diktat, but by blending millions of free voices into one harmonious melody.

Today, India is the fastest growing large economy. Our citizen-centric governance model takes care of even our most marginalised citizens, while nurturing the creative genius of our talented youth.

We have tried to make national development not an exercise in topdown governance, but rather a citizen-led "people's movement."

We have leveraged technology to create digital public goods that are open, inclusive and inter-operable.

NEDALESE GENERAL ELECTION 2022

Prime Minister Sher Bahadur Deubaled Nepali Congress on 7 December 2022 emerged as the single largest party in the House of Representatives with 89 seats after the election commission allocated seats to all the political parties under proportionate voting system. Seven political parties have got the recognition of the national party in the election though 12 political parties have won parliamentary seats.

This is good news for India. In fact, if the NC had not emerged as the largest single party to triumph in the polls, it would have further tempted China to unite all the communist parties leading to the emergence of a new government led by the Communist Party of Nepal-Unified Marxist Leninist (CPN-UML), backed by a few smaller parties or independents.

While Nepal's results are expected to suit India, New Delhi, nevertheless, has its task cut out in the Himalayan state. It includes deepening peopleto-people ties, which means engaging with some of the new faces and influencers thrown up by the polls, and structurally integrating Kathmandu in India-centred subregional connectivity projects.

After Nepal, India's next geopolitical challenge would be to pushback Chinese inroads in Bangladesh and the Indian Ocean Region (IOR). Bangladesh goes to the polls next year. In the IOR, China has made it plain that it would contest India's influence in these waters. China International Development Cooperation Agency (CIDCA), a government agency headed by former vice foreign minister and Chinese ambassador to India, invited 19 countries including all countries from South Asia sans India for the virtual event. During the meeting, China proposed to set up a marine disaster prevention and mitigation cooperation mechanism-a fig leaf for anchoring its geopolitical influence in the IOR.

1st G20 Sherpa Meeting



The 1st Sherpa Meeting of India's G20 Presidency, chaired by G20 Sherpa Shri Amitabh Kant, is commencing on 4 December 2022 in the historic city of Udaipur. The fourday gathering of the Sherpas of G20 Members, invited countries and International Organizations, will set the stage for important conversations on some of the most pressing issues of our time, including technological transformation, green development and LiFE, spotlighting women-led development, accelerating implementation of the SDGs, facilitating inclusive and resilient growth, and multilateral reforms.

The first G20 Sherpa Meeting under



India's Presidency sets the tone and agenda for future meetings, during which, India will have the opportunity to convene discussions on shared global priorities with G20 Members and Guests. The Sherpa meeting in Udaipur will work towards building consensus on a diverse range of global issues in various G20 Workstreams, and bring the focus to key global priorities.

The Meeting will have a panel discussion on accelerating implementation of the SDGs. Formal Sherpa discussions will be spread over five sessions and will be held on 5-6 December 2022. During these sessions, India will introduce the broad priorities of all the Working Groups and also hear the views of the G20 countries, guests and International Organizations. An informal session for free-flowing discussions among G20 Sherpas without any set agenda is also being planned.

The first Sherpa meeting will also offer the delegates a unique 'Indian experience' through cultural performances, art exhibitions, and excursions to various destinations including locations such as the Kumbhalgarh Fort - a UNESCO World Heritage site, and the Ranakpur Temple Complex.

In keeping with our G20 Presidency motto "Vasudhaiva Kutumbakam" and the theme "One Earth. One Family. One Future", the discussions will focus on finding holistic and harmonious solutions to prevailing challenges.

First MEETING OF THE G20 DEVELOPMENT Working Group

The first meeting of the Development Working Group (DWG) under India's G20 Presidency is taking place in Mumbai from December 13-16, 2022. G20 Members, Guest countries and invited International Organizations would be attending the meeting in person.

On December 13, 2022, the Indian Presidency will hold two side events - on "Data for Development: Role of G20 in advancing the 2030 Agenda" and "Infusing new LiFE into Green Development" - before the official meeting of the Working Group.

The Development working meeting will be held on December 14-15, 2022, with a focus on India's key priorities relating to accelerating progress on the SDGs, Lifestyle for environment and data for development.

India's G20 Presidency lies at a crucial midpoint of the 2030 Agenda for Sustainable Development, adopted in 2015. Review of SDG progress and G20's efforts to achieving the SDG targets would be discussed at the DWG meeting. In the context of Green Development, focus areas would include climate finance and technology, as well as just energy transitions for developing countries. Understanding that the issue of climate change cuts across industry, society, and sectors, the concept of LiFE (Lifestyle for Environment), a behaviour-based movement that draws from our country's rich, ancient and sustainable traditions, to nudge consumers, and in-turn markets, to adopt environmentally-conscious practices, would be deliberated upon. LiFE ties closely with India's G20 motto 'Vasudhaiva Kutumbakam' and theme "One Earth One Family One Future". With our human-centric approach to technology, tech-enabled development in sectors ranging from agriculture to education would also be discussed. Women empowerment and representation, including efforts to bring women to the fore, and in leading positions, in order to boost socio-economic development and achievement of SDGs, would be highlighted.

RACHNA SINGH, THE FIRST SOUTH ASIAN WOMAN **BECAME Education Minister in British Columbia**



A native of Punjab and a three-time MLA from Surrey Green Timber, Rachna Singh (49), created history by becoming the first South Asian woman to become Education and Childcare Minister of British Columbia province in Canada. She is the second Punjabi after Moe Sihota to handle the portfolio. Her parents Raghbir Singh and Mother Sulekha, besides sister Sirjana are teachers.

Rachna Singh said, "I'm really excited to take on this role and work with school boards, teachers and stakeholders to ensure all students have the support they need to be successful." She further said, "I am proud to be a part of the government that listens and cares for the people. We are committed to free and accessible education to all." "We are committed to make sure all children receive a high quality education in safe classrooms. We have done a lot, but there is more to do.

Rachna, who earlier worked as parliamentary secretary for racism in the Cabinet, continues to take part in anti-racism drives as well. Prior to her election to the legislature, she worked as a psychologist and drug and alcohol counsellor. She became active in her local labour union and eventually became a national representative (staff) for the Canadian Union of Public Employees representing workers through advocacy in grievance handling and labour arbitration. She moved to Canada along with her husband and children in 2001 and worked with CUPE as a social worker before being nominated as candidate for Surrey-Green Timbers by the NDP.

S Jaishankar visited US to Preside over 2 High-Level Ministerial Events at UNSC



External Affairs Minister Dr. S Jaishankar is presiding over two High-Level Ministerial signature events of India's ongoing Presidency of the United Nations Security Council in New York.

The High-Level Ministerial Open Debate is currently underway on the theme of "New Orientation for Reformed Multilateralism and the High-Level Briefing tomorrow is on Global Approach to Counter Terrorism - Challenges and Way Forward. Both these themes have been key priorities for India during its

current tenure at the UN Security Council. Dr Jaishankar emphasized the need to increase stakeholdership and enhance the effectiveness and credibility of multilaterism. External Affairs Minister S Jaishankar while addressing the meeting on 15 December said that multilateral platforms are being misused to justify and protect perpetrators of terrorism. He said, even as the world is coming together with more collective responses to the challenge of terrorism, multilateral platforms are being misused to protect perpetrators. Dr Jaishankar was apparently referring to China, which has placed holds and blocks on bids by India and the US on many occasions to blacklist Pakistanbased terrorists like Jaish-e-Mohammed chief Masood Azhar. Dr Jaishankar also slammed Pakistan for raking up Kashmir issue at the UN gathering to discuss the issue of multilateralism. He said, this is not the

first time Pakistan has used the UN stage meant for multilateral agenda to discuss its bilateral issues.

Stressing the need for reforms in the United Nations, Dr Jaishankar said the question before us is how best they can be reformed, particularly as the need to reform is less deniable with each passing year. He said recent concerns over food, fertilizer, and fuel security were not adequately articulated in the highest councils of decision-making. Much of the world was therefore led to believe that their interests did not matter. We cannot let this happen again, he said.

Dr Jaishankar said that when it comes to climate action and climate justice, the state of affairs is no better. Instead of addressing the relevant issues in the appropriate forum, we have seen attempts at distraction and diversion, he said.

Mahatma Gandhi's sculpture unveiled at United Nations headquarters



United Nations Secretary-General Antonio Guterres said that Mohandas Karamchand Gandhi was an uncompromising advocate of peaceful co-existence, nondiscrimination and pluralism. Guterres made the remarks while unveiling a bust of Gandhi at the United Nations headquarters in New York on 14 December 2022. India's External Affairs Minister S Jaishankar was also present during the inauguration. The bust, a gift from India to the United Nations, was designed by sculptor Ram Sutar, who also made the Statue of Unity in Gujarat.

<u>Guterres</u> said that Gandhi recognised India's diversity as one of its greatest assets and strove for harmonious relations between religions, cultures and communities. "His legacy is everywhere, including in the daily work of the United Nations around the world for equality, solidarity and empowerment," he said. "I hope the

He added that as the world grapples with violence, armed conflicts and humanitarian emergencies, the ideals of Gandhi must guide our actions to ensure peace and stability. "I sincerely hope that the sculptural presence of Mahatma Gandhi in these hallowed premises will inspire the United Nations to live up to its founding ideals," he said.

Indian expats to send record \$100 billion Home in 2022 - World Bank Report

India is likely to maintain its lead as the top recipient of remittances from expat workers in 2022 as well. According to a World Bank report, remittances to India are set to rise 12% in 2022 to a whopping \$100 billion, accounting for a bulk of \$163 billion in payments sent to all South Asian nations during the year. It is for the first time that any single county will receive \$100 billion in a year, said World Bank.

Overall global remittances to low and middle-income countries (LMICs) grew just 5% this year as compared to a 10.2% rise in 2021. Such payments are a vital source of household income in poor and middle-income countries. They alleviate poverty, improve nutritional outcomes, and are associated with increased birth weight and higher school enrollment rates for children in disadvantaged households, the World Bank said.

Remittances to India were enhanced by wage hikes and a strong labor market in the United States and other OECD countries. In the Gulf Cooperation Council destination countries, governments ensured low inflation through direct support measures that protected migrants' ability to remit. Sending \$200 to the region cost 4.1% on average in the second quarter of 2022, down from 4.3% a year ago.

"Migrants help to ease tight labor markets in host countries while supporting their families through remittances. Inclusive social protection policies have helped workers weather the income and employment uncertainties created by the COVID-19 pandemic. Such policies have global impacts through remittances and must be continued," said Michal Rutkowski, World Bank Global Director for Social Protection and Jobs.

Indian student inspires 'plogging' across UK

An Indian student and award-winning environmentalist from the University of Bristol in south-west England has inspired a trend of plogging, or jogging combined with litter picking, across various cities of the UK. Vivek Gurav, originally from Pune, was inspired by the Swedish concept of "plogging", which combines "jogga" (jogging) with "plocka upp" (a pick-up), to encourage people take pride in keeping the streets clean.

In India, he set up a plogging community known as "Pune Ploggers" back in 2018, with over 10.000 members who have collected over 1 million kilograms of rubbish and wanted to continue the trend when he took up his scholarship position at Bristol University in September last year. Since then, his university says he has covered over 420 miles on 120 plogging "missions" joined by volunteers from 180 countries and is now taking the

Presidential Speech of 10th World Roma Congress (International Romani Union), Riga

Let me congratulate you all on the 10th Congress of the International Roma Union (IRU), which I am pleased to host for the second time in a row in my native place Riga. This congress also has a special significance in a historical context since it is taking place after a worldwide pandemic and in a place where artillery is thundering and rockets are exploding a thousand kilometers away. Unfortunately, we cannot deny that we live in uncertain times, so we gather around us reliable people. I would like to believe that the IRU is a group of reliable people. One who believes in possibilities and who keeps hope despite hardship. We did not have the opportunity to meet when IRU celebrated its 50th anniversary, so I invite everyone today to unite in wishing our organization a long life!

This congress has a special significance, because this is the very last moment when we can hold all the 25 million Roma in all the different countries in one palm, find the strength to unite them and stand next to other nations on the geopolitical stage as equals.

We have gathered today at a crucial time for all civilizations! Since we last met seven years ago, man-made disasters, armed conflicts, cataclysms caused by global climate change, social upheaval and moral degradation have wreaked havoc, claimed lives and driven more and more people into poverty. The poor have become poorer while the rich have consolidated their wealth and power.

The pandemic claimed more than 6.6 million lives. None of us were ready for it. It deeply touched and influenced our nation as well. Today I cannot but mention the departed great spirits of our nation - Marcel Courthiade, Viktor Famulson, Raino Djuric, Kujtim Pacaku, Trajko Petrovski and Estrefan Abdiezamanovski who supported the international Roma community and whose wit and wisdom we miss so much today. I am inviting all of us to honor their memory with a moment of silence.

Unfortunately, my speech today won't be full of joy. I want to touch on all the main issues and I will do it sequentially. There is a saying - if you want to see your worst enemy, look in the mirror. In my opinion, this is well said about all of us. We can point fingers at Europe, we can blame our municipalities, mock the concept of family and marriage, we can curse each other on social networks, and this will only contribute to the negative spiral that has divided our people and scattered them around the world in recent decades. Gone are the days when we greeted each other on the street because we recognized each other. Young people of a certain age no longer want to be associated with Roma. Our literature is being polluted, as are our language and traditions. It is regrettable that the law of kin or Romanipen, which our fathers and grandfathers kept sacred, is dying out nowadays. Globalization and Romaphobia have succeeded in dividing us, making us indifferent and apathetic. Western civilization has succeeded in forcing our faces to the ground and silencing our voices. The last century has done more harm to the Roma people than the last nine hundred years we have spent in exile. Today I am going to invite you to go back to your roots and start realizing your worth. But before that, let me crunch some numbers.

Recently, the European Union Agency for Fundamental Rights (FRA) published an extensive study on the living standards of Roma in ten European countries. Many spheres of life of more than 20,000 Roma families were carefully studied in comparison with other peoples living

in Europe. 8500 people were interviewed and the results can be called scary without exaggeration. More than 80% of our families in Europe are below the poverty line. The European average is 17%. 71% of European Roma do not have primary education. For other nationalities, this indicator is 10%. In Europe, 61% of Roma families live in inadequate conditions, often without basic amenities, and 22% of them do not even have running water. The average life expectancy of Roma women is 11 years less than the average in Europe - 71 years compared to 82 years for other nations. Not much better with men. Roma men live an average of 67 years, other men in Europe - 76 years. So, on average, we live ten years less than other nationalities. If that can't be called extinction. I don't know what can.

What I am about to say will sound unpopular, but it's nobody's fault but ourselves. In the 50 years since the International Roma Union has existed, no one, including me, has managed to make it an organization that is respected by the leaders of European countries and international organizations. We still do not have our own budget and an administration functioning according to all the principles of good governance. The very fact that you are here is a miracle, the IRU does not have any internal rules and regulations governing the manner in which we come together, apart from the internal agreement that congresses are held once every four

years.

Have we really not understood that the issues of education, social needs and poverty of the Roma people cannot be solved by anyone but ourselves? How long will we beg with an outstretched hand in Brussels and to the governments of our countries, which at best give us handouts? Who is to blame for the fact that the whole world knows about the Holocaust, but does not know about Samudaripen the genocide against the Roma people? And what is to blame for the fact that we take for granted a situation in which European institutions allocate billions of euros to Roma issues, which never reach their intended recipients? I'll tell you straight - our indolence, laziness, envy and inability to work together in recent decades is to blame.

According to my calculations, in the last twenty years, the European Union has allocated more than 150 billion euros to Roma issues in various aid and integration programs. Have any of you, esteemed colleagues, felt even a small part of this 150 billion euros on your skin? This money has been mismanaged, distributed to their own, it has been paid to various officials who write glowing reports to Brussels, but the situation of the Roma does not change, it does not change. I have personally submitted 25 applications to various European institutions and funds over the past six years, the purpose of which was to solve the problems mentioned above. Amounts requested ranged from 100,000 to 2 million. No one, and I repeat - no one from our projects received support, considering that the best consultants worked on them. European officials are not interested in strong Roma organizations, because then they will be deprived of the opportunity to divide the funding meant for us among themselves and redistribute it in their own programs.

The head of the European Union Agency for Fundamental Rights, Professor Michael O'Flaherty, honestly states that many programs aimed at improving the lives of Roma people have been formally implemented for many years, but have not produced real results.

As I run for the presidency, I offer a clear strategy for Roma in India- a country that is ready to issue permanent residence permits to Roma. A few years ago, Roma relations with India reached an all-time high in our history. The Indian government recognized us as an equal diaspora of their country and that a thousand years ago the Roma were forcibly removed from the territory of North India where they originated from.

India today is in a unique situation. The oldest culture, millennial traditions, a perfectly developed economy, the highest authority in the world and almost one and a half billion people. Thanks to these qualities and leadership wisdom, India has not allowed itself to be drawn into a bloody armed conflict and no less bloody economic and hybrid wars that are tearing the planet apart. India has carefully maintained its neutral status, friendly, cultural, economic and trade ties with all parties to the wars and conflicts that are tearing our land apart. India has not broken relations with anyone and even more - recently it has noticeably strengthened them. Money and goods move freely between India and any country irrespective of which side they are on.

In this critical situation, working shoulder to shoulder with the people of India, we can and must become ambassadors of goodwill and good intentions. We can help the people who are suffering from the brutal sanctions wars of feverishly closed borders. Scattered around the world, Roma are included in the highest political, business and financial circles of the countries in which we live. We know all their needs and problems. We have raised outstanding scientists, politicians, businessmen, intellectuals in the broadest sense, not to mention worldfamous artists and musicians. Our greatest potential is in our youth. Boys and girls are brought up in the traditions of our people, knowing and respecting our history and culture. Many of them have received quality education. With the desire for higher self-realization characteristic of young people, they are ready to "play by the rules of the world around us" and raise their social status in it. We do everything we can to support these young people in their endeavors. We were confident then and we are confident today that more than 25 million Roma can adequately represent the interests of Mother India throughout the world.

Bhutan's contingent, which comprises of 180 Royal Bhutan Army Personnel, is part of the United Nations' Multidimensional Integrated Stabilisation Mission for the Central African Republic (MINUSCA).

The rear team of Bhutan's United Nations Peacekeeping Contingent was seen off in a ceremony at Paro Airport before they boarded a special Drukair flight to the Central African Republic on 10th November 2022.

As with the main contingent, His Majesty The King and Her Majesty The Gyaltsuen graced the ceremony, which included the offering of Marchang and Guard of Honour.

The Prime Minister, Foreign Minister, Chief Operations Officer of the Royal Bhutan Army, IMTRAT commandant, and senior government officials also attended the ceremony.

UK, FRANCE AND UAE EXTEND SUPPORT FOR INDIA'S PERMANENT MEMBERSHIP AT UNSC

The UK, France, and UAE have extended their support for India's permanent membership at the United Nations Security Council (UNSC). India is holding the presidency of United Nations Security Council for the month of December 2022. The UK Permanent Representative to the United Nations, Dame Barbara Woodward, said, the Security Council must become more representative of the world today and the UK has long called for its expansion in both the permanent and non-permanent categories. She said, as the UK Foreign Secretary publicly reiterated this week, the country support new permanent seats for Brazil, Germany, India, and Japan.

Permanent Representative of France to the UN, Ambassador Nicolas de Riviere, has said that they support an expansion of the Security Council to take into account the emergence of new powers that have the world and the ability to shoulder the responsibility of a permanent presence on Security Council. He said, France thus supports the candidacies of Germany, Brazil, India, and Japan as permanent members.

The United Arab Emirates also reiterated its endorsement of India's bid for permanent membership of a reformed security council. Speaking at UNSC Open Debate on 'Maintenance of International Peace & Security: New Orientation for Reformed Multilateralism, UAE Minister Noura Bint Mohammed Al Kaabi ' said, India's voice at this chamber is necessary and UAE reiterates its endorsement of country's bid for permanent membership of the reformed UNSC.

The UN Security Council is the premier global body for maintaining International peace and security. The Security Council, the United Nations' principal crisis-management body, is empowered to impose binding obligations on the 193 UN member states to maintain peace.
