Mauritius - My Second Home

(Continued from the Previous issue)

Immigration to Mauritius

Immigrants arrived in Mauritius in October 1834 and this process continued till 1910. Mauritius decided to celebrate the 150th Anniversary of Indian Immigration in a big way and a National Committee with Shri Uttam Bissoondoyal was constituted for this purpose. The Antar-Rashtriya Sahayog parishad also set up a National Committee in Delhi with Shri Bhisma Narayan Singh as its President in February 1984 to coordinate all the activities in connection with the celebrations in India and Mauritius. Only a month later, Shri Bhisma Narayan Singh was appointed Governor of Assam and he could not continue as the President of the National Committee. Shri Bhagwat Jha Azad, MP (now Chief Minister of Bihar) was elected president of the committee and it started working in the right earnest. The Government of India also extended its full cooperation for all the projects that were undertaken by this committee. It organised an essay competition on Indo-Mauritius Relations 1834-1984 for the college students; and a seminar on the "People of Indian Origin Abroad- Problems and Prospects" on the 11th October, 1984 which was inaugurated by Shri Balram Jakher, Speaker of Lok Sabha. It also organised an exhibition of books, periodicals, maps and photographs in the AIFACS hall. It set up a documentary ballet "Sona Ke Khajanwa" which was directed by

All the members The first batch of the Indian of the delegation were guests of the Reception Committee and stayed with Indian families. I stayed with Shri Vissoo Ramphul, Chairman Swastika. A new bond of friendship was developed between the members of the delegation and the families where they stayed. It was a unique experience for all of them. They were strangers when they met but became family members when they parted company on the 29th October. The host families came in full strength and saw us off at the airport with tears in their eyes. Such were the memorable experiences of the delegation members that we decided to publish "Mauritius Me Saat Din" which was released by Smt. Ramdulari Sinha, leader of the delegation as Shri Bhagwat Jha Azad could not go because of personal reasons.

> It was during this visit that one lakh "Ganga Jal" bottles were taken to Mauritius and distributed among the Hindu families by the workers of Human Service Trust.

This visit to Mauritius had a profound impact on me. I had retired from the Chief Editorship of Hindusthan Samachar in May 1982 and had taken up the social work for the Overseas Indians through the Antar-Rashtriya Sahayog Parishad. Quite naturally in two years time, I tried to study the immigration of Indians to various parts of the world. Mauritius was one country where there were no original Smt. Mauritius became more frequent.

Meanwhile, contact with Mauritians had developed so much that anyone coming from that country would contact me. The Mauritian students studying in Delhi colleges would contact me for so many things. My office became almost a meeting point for the Mauritians. Our students' wing organised visits to cultural centres like Badrinath-Kedarnath. Haridwar-Rishikesh, Dehradun from time to time. The Mauritian students participated in these programmes in a big way. The Mauritius High Commission in Delhi was closely associated with our activities and gave its blessings for all our projects. The Africa Division of External Affairs Ministry also realised the good work being done by extending its cooperation from time to time. The Indian Council for Cultural Relations supported us in organising visits to various centres for the foreign students. Many industrialists, who intended to set up some industries in Mauritius, contacted us for all possible information. Thus, our office had become a nerve centre for all activities connected with Mauritius.

Ayurvedic Centre

Vaidraj Pt. Jagdish Prasad Sharma. President of International Institute of Ayurvedic Sciences, has been visiting Mauritius from 1973 for exploring the possibilities of opening an Ayurvedic Centre in Mauritius. It was only in 1984, during the 150th Anniversary Celebrations of the Indian Immigration to Mauritius that he could move ahead in this direction. The Sanatan Dharma Temple Federation, Mauritius assured him to extend full cooperation in this venture. It, however, could not go ahead because of the local problems. Ultimately, I had to go to Mauritius in July 1985 to finalise all local arrangements and it was decided that the Ayurvedic Centre would be started in Calebasses Ashram run by the Human Service Trust.

India-USA Relations would continue to Progress in Biden Presidency

concern in India at the change of guard in USA with the election of Democratic candidate Joe Biden as the new President, particularly since the relations registered remarkable progress under Pres. Trump, given his firmdetermination to deal with China headlong and his hardline views on Pakistan's complicity and direct involvement in international terrorism. Warm personal chemistry between him and PM Modi also, no doubt, has been seen as a positive contributing factor.

However, it needs to be noted that Biden has been very supportive of strong ties with India. As Chairman of powerful Foreign Affairs Committee of the Senate, he played a pivotal role in getting the India-US civil nuclear cooperation agreement cleared. Later, he served as Vice President in Obama administration when US and India signed LEMOA paving the way for India's recognition by USA as a 'major defence partner' and license free access to a wide range of dual use technologies.

Writing in an ethnic Indian community journal, Biden promised that his administration would "build on the great progress" made in the relationship during Obama years. He also asserted that India and USA "can and should be natural allies."Significantly, Prime Minister AtalBehari Vajpayee had also described India-USA relationship as being that between natural allies.

In geo-political terms, it is widely expected that the firm line against China initiated under Trump presidency would broadly continue because of rather combative stance of China, which seems to be in a hurry to assert its primacy on the global stage. Its aggression against India and other neighbouringcountries surrounding South China Sea has also not gone unnoticed by Biden team. In fact, Starting with the 'General security of Secretary of State nominee Blinken

Under these ements at the circumstances it can be expected that recently USA under Biden would continue to concluded regard India as a 'key partner.'Notably, India's External Affairs Minister with the Jaishankar while commenting on this issue, expressed his confidence that Indo-US relations could only move up further in the coming months.

> Presence of Kamala Harris as Vice President and likely induction of several PIOs in senior position in the new administration is also a factor which would favourably impact on the relationship. In fact, election of a PIO as the Vice President of the country itself is a landmark development. The credit for it obviously goes to Biden for having chosen Kamala Harris as his running mate, but It also signifies the coming of age of the vast and influential Indian community in USA. It is well recognized that given their large numbers and relatively high income levels, PIOs in USA have begun to play increasingly salient role in the country's politics and in providing a generally positive thrust to furthering India-US ties.

> In the last two decades there has been a steady and continuing growth in Indo-US defence and intelligence cooperation despite government changes in both countries indicating a broad bipartisan support on both sides for closer relations. Shared democratic and liberal values and generally positive perception that both countries have about each other have, no doubt, contributed to creation of a positive climate but there denying that common threat from China and consequent convergence of geo-political interests hasmainly brought the two countries together.

geo-spatial intelligence. In the meanwhile, USA has also eased export restrictions on India for high tech equipment including sensitive defence technologies by designating it as a 'Strategic Trade Authorization-1(STA-1)' country even though India is yet to gain entry into the NSG club. In fact, USA has emerged as a major arms supplier to India over the last few years. This momentum is bound to continue because both countries face the joint challenge of countering China's growing military weight. India and USA also actively cooperate in countering terrorism, another major threat to the world peace and stability. There are understandable concerns in India about the need to maintain country's strategic autonomy but that does not get compromised by a closer military coordination with USA in order to deal with our existing security threat perception.

India has a massive economic and commercial relationship with USA with trade in goods and services totaling US \$ 150 billion. Unlike China with whom we have a huge deficit, India enjoys considerable trade surplus with USA. Energy partnership has also emerged as an important constituent of that relationship contributing greatly to India's quest to diversify its sources of energy supplies.

Biden has been quite emphatic about bringing USA back into the Paris climate accord and in ensuring greater coordination and alignment with the

allies on global political and economic western countries. China's dubious region and indeed the world at large issues. India's sterling record on role in the spread of virus and promised reduction of emission levels suppression of information in the early jells quite well with his priorities.

It is widely expected that under Biden USA will seek to reclaim its centre stage role in global affairs which could, inter alia, see it playing a reinvigorated role in Indo-pacific region involvingcloser coordination with India and traditional allies such as Japan and Australia including military and maritime exercises to enhance interoperability both in bilateral and 'quad' framework.

The onset of Covid-19 pandemic which has affected millions across the world resulting in heavy casualties, would in all likelihood deepen the fissures between China and the

stages has already come in for sharp criticism by western leaders and general population alike. Consequently, one could well see the western countries acting in concert to keep China's rise in check and India could play a pivotal role in that effort. the manufacturing facilities out of China and India could offer itself as a credible alternative if we were to take further steps to improve the manufacturing climate in India and bring our practices and regulations more in line with the international best practices.

To conclude, the evolution of geopolitical dynamics in the Indo-pacific and emergent threat from China's aggressive posture would require both India and USA to continue to work as close strategic partners. Based on current indications and affirmations on both sides, the cooperation between them at the government level would further solidify.

International Scientific Colloquium-5 & 6 Nov. 2020 AT INALCO

Rromani Millennium: Results And Prospects (1001 Years in Diaspora)

This Colloquium was organised by PLIDAM laboratory in order to celebrate four significant dates:

World Day of the Rromani language (a UNESCO day: 5 November)

O Baro TelÎripen - The Great Departure (beginning of 1019 AD)

Six hundred years of attested presence of Rroms in France (August 1419)

Thirty years of the Rromani unified alphabet and spelling (adopted at the Warsaw Congress, April 1990) Nov. 5 (Thursday)

The Colloquium was opened at 9:30 a.m. by the President of the PLIDAM laboratory, Prof. Thomas Szende (Paris and Oxford) who underlined the importance of recent results achieved in Rromani linguistics and History, not only in a scientific perspective but also as to serve the advancement of didactic methods and social justice. On the basis of various examples he reminded that these are precisely the goals of PLIDAM.

His keynote was followed by a very supportive allocution by Mr. Paul de Sinety, Delegate general of the General Delegation for the French Language and the Languages of France (DGLFLF), an executive body of the French Ministry of Culture and Communication. He underlined the importance DGLFLF devotes to the recognition and development of Rromani as one of the acknowledged languages of the French Republic. DGLFLF supports the present Colloquium. Commemorating the departure of the Rroms' ancestors from Kannauj (U.P.) one thousand years ago provides a great opportunity

> After the reading of the message sent by Mr Xing Qu, number two of UNESCO on behalf of Ms. Audrey Azoulay, Director-General of the UNESCO, Mr. Siniša Šešum, Head of the Sarajevo Office of UNESCO, welcomed the participants of the Colloquium and highlighted the need of a universal recognition of Rromani as a well established language, with a rich heritage and a vocation of linking nations as a bridge, mainly within Europe but also between continents. The Sanskrit roots of Rromani are of special significance as a living testimony of this umbilical link of the Rroms with India.

The floor was then given to Dr. Normunds Rudeviès, President of the Maœkarthemutni Rromani Unia (International Rromani Union), who underlined the historical ties of the Rromani nation with India, as the very first diaspora from this cradle of a very rich diaspora. He opened then a series of issues of political, cultural, economical, and social and ethical character, as a programme of action for the second millennium of the Rroms in diaspora.

Prof. Marcel Courthiade paid a heartfelt homage to late Smt. Sushma Swaraj, former foreign minister of India, mentioning this prominent statesperson's personal involvement in the recognition of the Rroms as an Indian diaspora. He finished his homage with a quotation by late Sushma Swaraj, pronounced during a meeting in 2018 at her office with the delegation of 30 Rromani scholars from all over the world.

Rajko Đuriæ, a Rromani poet and researcher, doctor in sociology, Sanskritist and philosopher, former president of the International Rromani Union (two mandates: 1990-2000), a devoted and proud son of India, prominent fighter for justice for the Rromani people in a context of global justice and peace but also professional journalist.

The first scientific session was devoted to History, with four presentations:

- First Mr. Zameer Anwar, Research Assistant with Centre for Roma Studies and Cultural Relations (CRSCR, ARSP), New Delhi, devoted his paper to a state of art report on Researches in India devoted to the Roma studies. This contribution was very informative and comprehensive because it shed light on a quite unknown chapter of the relations in India between European Roma and India.
- The second speaker, Me Daniel Vasile, lawyer and MP as representative of the Rromani minority to the Parliament of Rumania, was unable to attend directly the meeting due to his parliamentary agenda but he had sent 20 min. movie about the fate of the Rroms after the abolition of their 500 year long slavery in Rumania 1385 up to 1855-1856. His written contribution, more specific in terms of historical research, was also sent for

- former Ambassador of Serbia to Ottoman rule and focused after that on a little known event which occurred during WWI when a Yugoslav Rrom, named Ademoviæ, managed to reverse the course of a major battle between Serbian and Turkish armies.
- The last presentation of the historical session, by Bernard Mossé, head of the section of Research and Training at the Camp des Milles Museum-Memorial in Aix-en-Provence and coordinator of the UNESCO chair « Education for Citizenship, Human Sciences and Shared Memories", was devoted to a presently burning issue, namely Samudaripen, Shoah ...: for a convergence of the memory of genocides because as he explained only a common approach can build up a firewall against the risk of repetition of such calamities, whereas separate initiatives have resulted too weak in this respect.

The second scientific session, with Dr Mila Dragoviæ as a chairperson, was devoted to Linquistic, also with four presentations:

 the introductive input was delivered by the Rromani poet and teacher from Serbia Ismet Jašareviæ, who reminded the first stages of the emergence of a project of common script for diverse dialectal varieties in use in Southern Yugoslavia. His testimony was continued by Dr. Marcel Courthiade's presentation. He is the commissioner for language and Linguistic Justice of the International Rromani Union and head INALCO Paris-City Sorbonne (department of Southern Asia and Himalaya). His report covered the evolution of the Affirmation and standardisation of the Rromani language: results and prospects, and attempted to describe the various linguistic, political and epistemological

- Dr. Darko Tanaskoviæ, professor factors explaining the atypical emeritus, University of Belgrade, development of this process. He highlighted that Rroms agree as a rule UNESCO and dean of the diplomatic to the linguistic policy conducted by corpse presented first an overview of the IRU but that some amateur the fate of the Rromani people under outsiders interfere to block any progress, for reasons which are also depicted in the contribution.

- the second presentation, delivered by Dr Shashi Bala, professor of Sanskrit, dean of the International Academy of Indian Culture and president of the Centre of Indology Bharatiya Vidya Bhavan in New Delhi was of prospective character: Sanskrit and rromani: setting forth an agenda for further research in diachronic linguistics. As she underlined there is a lot to do in this field, task force does exist, not only in Europe but also in India. After an overview of research led so far, she itemized some tasks which have not yet been treated properly so far and need more research.
- Dr. lan Hancock, professor emeritus, University of Texas in Austin, participated with an updated research entitled Comparative grammar in the service of dating historical facts: the neutral gender of substantives in languages from Sanskrit, which is one of the key facts allowing a precise dating of the Proto-Rroms' dislocation from central U. P. – the area identifid by Sir Ralph Liley Turner as the cradle of the Rromani language and therefore its speakers.
- the last contribution of this session was produced by Masako Watabe, PhD student at INALCO and professor of Japanese language, who is devoting her research to the topic presented here: Developing a NooJ platform for Rromani and of the chair of Rromani studies at computerizing educational material for this language. Her research is really innovative because it is the first time in computational linguistic that a multicentric language is treated as such.

The third session of the day, entitled Educational and documentary resources, consisted in three presentations:

- Nicolas Pitsos, of the BULAC (University Library of languages and Cultures, doctor in History and associate member of the Centre of Research in European Studies) gave a rich account of available Documentary Resources on Rroms and Rromani. He underlined that the BULAC is in possession of a copy of the Arabic original of the Kitâb al-Yamînî, the book by Al-'Utbi, which confirmed his patron sultan Mahmud's part in the Proto-Rroms' dislocation from Kannauj. He also mentioned the exhibition organized at BULAC at the beginning of 2019 to commemorate the Millennium of the Exodus - where this rare book was shown.
- Dr. Mila Dragoviæ presented a slideshow of the exhibition The Rroms and Rromani: an Asset for Diversity and Education, presented in prestigious places as the Council of Europe in Strasbourg, the Azad Bhawan in New Delhi (where it was inaugurated by late Sushma Swaraj) and the National Museum in New Delhi two years later. This exhibition is the result of cooperation between the INALCO Chair of Rromani and the IRU Foundation Rromani Baxt (Warsaw-Paris-Tirana).
- the last contribution was by publisher Zlatomir Jovanoviæ, director of Rrom produkcija publishing house (Belgrade), with a comparatively rich catalogue of Rromani books of literature, science, didactic material and other fields of knowledge.

The Colloquium had after that the privilege of welcoming the Rromani poet Alexandre Bouglione, whose book Of blood and gold was published in French, rromani and Serbian, with many photographs of the author. Larges excerpts were read to the audience in these three languages by the author and his translators, who were attending the Colloquium.

London Council Clears Ambedkar House for **Operation As Museum**

The Inspector oversaw an inquiry into the Indian government's appeal last year and presented his findings to the minister.

Local authorities in north London have formally cleared the operation of Ambedkar House as a museum in honour of the architect of the Constitution of India after it was approved as a landmark associated with "one of the founding fathers of modern India" earlier in the year. Camden Council gave the final goahead for the museum after UK Communities Secretary Robert Jenrick had intervened to grant retrospective planning permission for 10 King Henry's Road in Camden, where Dr Babasaheb Ambedkar lived in 1921-22 during his student days at the London School of Economics (LSE).

However, the minister's March order. which came at the end of an inquiry following an appeal against Camden Council's planning refusal, came with a set of conditions. "The Camden Council has now given permission for the cycle stand and approved the Management Plan and therefore the conditions attached with the Secretary of the State [Jenrick] order dated 12th March 2020 stands complied with," Janeevan John, of Singhania & Co Solicitors which dealt with the appeals process for the Indian High The home was bought by the Commission in London, said in a statement on Friday. "The long-Museum is all set to start," he said.

The UK Ministry of Housing, Communities and Local Government stepping in meant that the government was to decide on the matter based on recommendations from an independent Inspector appointed by the UK's Planning Inspectorate. The Inspector oversaw an inquiry into the Indian government's appeal last year and presented his findings to the minister. "I was pleased to grant planning permission for a museum in The Indian High Commission in founding fathers of modern India and an important figure to many British Indians," said Jenrick.

Priscilla Jana, Lawyer Who Battled Apartheid, Is DEAD AT 76

Priscilla Jana, a forthright human rights lawyer died on Oct. 10 at a care home in Pretoria. She was 76. Ms. Jana was descended from a family of middle-class Indian immigrants. When she was 28 she heard a speech by the activist leader Steve Biko. "I listened to his definitions and was amazed," she wrote in "Fighting for Mandela," a memoir published in 2016. Ms. Jana felt an emotional turmoil inspired by her friendship with Nelson Mandela and Winnie Madikizela-Mandela, whom she had gotten to know as their lawyer when Mr. Mandela was serving his 27-year imprisonment, as the couple were torn apart in the early years of South Africa's emergence from apartheid. Such were the racial distinctions there that people classified as Indian, like Ms. Jana, were not even permitted to stay overnight. Ms. Jana regarded her role not simply as an attorney but as an activist linked to insurgents seeking the violent overthrow of apartheid. During business hours she worked on human rights cases, she wrote in her memoirs, but at night she joined plotting to bring down the government marriage, too, ended in divorce, in the

Devikarani Priscilla Sewpal was born on Dec. 5, 1943, in the town of Westville on the fringes of the South African port city of Durban, on the Indian Ocean. While studying in Mumbai, India - then known as Bombay - she met and later married Reg Jana, a fellow South African student. They divorced in 1989. She was later briefly married to a fellow activists "in an underground cell, lawyer, Reagan Jacobus; that

early 1990s. Ms. Jana is survived by a daughter, Albertina Jana Molefe, and a son, Shivesh Sewpal. While her parents had initially wanted her to become a physician, she switched to studying the law in South Africa and graduated in 1974. She then joined a firm run by Ismail Ayob, a lawyer of Indian descent whose clients included the Mandela family. In 1990, Nelson Mandela walked free. Four years later, in the country's first fully democratic elections, he was elected president. Ms. Jana took part in a candlelight vigil in Dublin on Dec. 9, 2008, the eve of International Human Rights Day. She was later a diplomat for nine years, serving as the South African ambassador to the Netherlands and Ireland before joining the South African Human Rights Commission as its deputy chairwoman in 2017. But she seemed dissatisfied with the way the post-apartheid authorities had run the country. "We finally put apartheid, colonialism and slavery behind us after 350 years, but we are not yet reaping the rewards of that great fight," she wrote in her memoir. "It is going to take much longer."
